**ORDER DENYING APPLICATION FOR MORTGAGE LOAN ORIGINATOR LICENSE**

Jacqueline N. McMillan filed an application with this Department for a Mortgage Loan Originator License (NMLS ID #122684) in January 2010. On September 22, 2010, the Undersigned sent notification to this applicant that he intended to deny the application due to the following deficiencies:


1. Applicant has not submitted authority to the NMLS for a background check as required under Section 5-26-11 of the Alabama SAFE Act.
2. Applicant's NMLS Record indicates that the applicant is not sponsored by any company. Therefore, the applicant is not covered by a surety bond as required under Section 5-26-14 of the Alabama SAFE Act.

The notice of September 22, 2010, allowed the applicant 20 days within which to correct the above deficiencies or withdraw the application. The applicant has done neither.

Therefore, for the above cited deficiencies it is the Final Order of this Bureau and this Department that the application of Jacqueline N. McMillan for a Mortgage Loan Originator license is DENIED.
